Updated Visiting Opportunities

Beginning on **April 2, 2021**, our Community will be open to visitors with the following guidelines:

- Advanced notice of visits is requested, but <u>not required</u>
- Visitors will have no restrictions on number or length of visits
- Visitors will self-screen at the front lobby of the building and take their own temperature. It is the visitor's responsibility to complete and submit the selfscreening tool at the designated Visitor Screening Station prior to proceeding to visiting with your resident(s). Visitor Screening Questions are attached to this letter for reference.
- There is no restriction on age groups coming to visit
- Face shields are recommended PPE, but not required

Please continue to:

- Follow social distancing guidelines at all times.
- Wear a face mask at all times. Each visitor must provide their own mask.
 If you are unable to provide your own, we will provide one at a small cost.
- Follow good handwashing practices.

In addition, our Visiting Booth remains open for scheduled visits. We also continue to encourage Skype, FaceTime, iN2L and Zoom calls in order to stay connected.



If we experience a case of COVID-19 or if local positivity rates or policy dictates, we will move backwards in phases to protect the residents and staff.
